I am directed to convey the sanction of President of India for the payment of grant-in-aid amounting to **Rs.10,28,17,608.00(Rupees Ten Crore Twenty Eight Lakh Seventeen Thousand Six Hundred Eight Only)** to the State Government of Himachal Pradesh S towards implementation of Action Plan under DDU-GKY by HPSRLMs for the financial years 2016-19. The Central Share of funds being released is calculated as follows:

The State Government shall transfer its matching share as per fund sharing ratio of 90:10, into the account of Himachal Pradesh State Rural Livelihoods Mission Society - "Chief Executive Officer, Himachal Pradesh State Rural Livelihoods Mission Society , **"UCO Bank, HPSRLM, HPMC Building, 2<sup>nd</sup> floor, Nigam Vihar Shimla and IFSC Code - UCBA0000981, Account No. 09810110038390"** positively within 3 days from the date of receipt of the said funds. In case of delay, the State government would be liable to pay interest@12% for the period of delay beyond the specified period. The State Government is requested to endorse a copy of the release order within 3 days of release of funds to
