**Sub:-** Release of 1<sup>st</sup> installment of central share of funds of the Project Cost and Support Cost of Action Plan 2019-22 to the State Government of Himachal Pradesh for implementation of placement linked Skill Development Project under DDU-GKY by Himachal Pradesh State Rural Livelihoods Mission Society .-Reg.

Sir,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to **Rs.12,91,95,000.00(Rupees Twelve Crore Ninety-one Lakh Ninety-five Thousand Only)** to the State Government of Himachal Pradesh towards 1<sup>st</sup> installment of central share of funds of the Project Cost and Support Cost approved in Action Plan 2019-22 for implementation of placement linked Skill Development Project under DDU-GKY by Himachal Pradesh State Rural Livelihoods Mission Society. The amount of Central Share proposed to be released as the 1<sup>st</sup> installment is Rs.25,83,90,000.00, out of this, **Rs.12,91,95,000.00** (50%) amount for General Category including Minority is being released under this order.

2. The grant- in- aid shall be utilized for implementation of DDU-GKY projects as per terms and conditions laid down in the DDU-GKY Guidelines and Standard Operating Procedures (SOPs.) and extant instructions issued from time to time. No deviation from the provisions of DDU-GKY Guidelines and SOPs for implementation of DDU-GKY Projects is permissible.

3. The State Government shall transfer its matching share as per fund sharing ratio of 90:10, into the account of Himachal Pradesh State Rural Livelihoods Mission Society - "Chief Executive Officer, Himachal Pradesh State Rural Livelihoods Mission(HPSRLM) Society , "ICICI Bank, Kasumpti Branch, SCO-14-15-16, Block No.3 SDA Complex, Shimla-171009, IFSC Code – ICIC0003668, Account No.366801000332" positively within 15 days from the date of receipt of the said funds. In case of delay, the State government would be liable to pay interest@12% for the period of delay beyond the specified period. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order within 15 days of release of funds to Himachal Pradesh State Rural Livelihoods Mission Society and to the Central Government addressed as under:-


6. No Utilization Certificate is pending against the Himachal Pradesh State Rural Livelihoods Mission Society under DDU-GKY.
