The State Government shall transfer its matching share as per fund sharing ratio of 90:10, into the account of Himachal Pradesh State Rural Livelihoods Mission Society "Chief Executive Officer, Himachal Pradesh State Rural Livelihoods Mission(HPSRLM) Society, "ICICI Bank, Kasumpti Branch, SCO-14-15-16, Block No.3 SDA Complex, Shimla-171009, IFSC Code ICIC0003668, Account No.366801000332" positively within 15 days from the date of receipt of the said funds. In case of delay, the State government would be liable to pay interest@12% for the period of delay beyond the specified period. The factum of release of these funds must be registered in the Public Financial Management System (PFMS).
