Subject:- **Release of 1st instalment of Central share** for implementation of National Rural Livelihoods Mission (NRLM)/Aajeevika during 2016-17 in **Himachal Pradesh State**.

Sir/Madam,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to **Rs.47,40,000/- (Rupees forty seven lakh forty thousand only)** to the State **Government of Himachal Pradesh** towards first instalment of Central share under National Rural Livelihoods Mission (NRLM) during the year 2016-17.

2. The State Government must transfer these funds along with the State share to the **CEO, Himachal Pradesh State Rural Livelihood Mission (HPSRLM), Central Bank of India, Kasumpti, Shimla-9, A/c No. 3142801305, IFSC Code: CBIN0283625** within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse a copy of the release order within 3 days to the Central Government addressed as under:

3. The accounts of the grantee institutions will be open to audit by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry.

4. The amount should be utilised on the Programme as per approved Implementation Framework of NRLM.

5. The funding pattern will be 90:10 by the Centre and State as per the revised funding pattern.

8. No Utilisation Certificate is pending against the Himachal Pradesh State Rural Livelihood Mission under this Scheme.

9. Assets acquired wholly or substantially out of this grants shall not be disposed of without obtaining the prior approval of this Ministry.

10. All expenditure will be subject to the ceiling/ranges of the units and unit cost as communicated by the Ministry from time to time.

11. The SRLM will not transfer any funds out of this grant to those districts who have not furnished UC and Audit Report under SGSY for the year upto 2012-13.
