Provisional Utilization Certificate for the FY 2018-19 has been received.

6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

7. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.

8. The expenditure covered by this sanction will be met from the funds provided under Deman No. 42, Major Head – 3601- Grants-in-aid to State Governments, Minor Head-06789-Special Component Plan for Schedule Caste, 13-National Urban Health Mission, Sub Head-1305-Other Health System for activities covered under NUHM-(Support from National Investment Funds-NIF), 130535-Grant for creation of capital assets during 2019-20.
