**Subject: Release of 1<sup>st</sup> & final instl as Grants-in-aid for assistance to Government of Himachal Pradesh under Deendayal Antyodaya Yojana - National Urban Livelihood Mission (DAY-NULM) during 2019-2020 - reg**

Sir,

I am directed to convey the sanction of the President for the release of the **First and final installment** of grants-in-aid amounting of **Rs 1,32,28,000/- (Rupees One crore thirty two lakh and twenty eight thousand only)** to Government of Himachal Pradesh as assistance under the Scheme of DAY-NULM for the year 2019-20 as per details below:-

2. The revised entitlement for the State of Himachal Pradesh for the year 2019-20 is Rs 572.00 lakh. Funds to be released as Central Share is **Rs 180.70 lakh** (General: Rs 1,32,28,000/-, SCSP: Rs 40,65,000/- and TSP: Rs 7,77,000/-), after deduction of Rs 391.30 lakh unspent balance available for previous releases under all categories (General, SCSP and TSP) as on 31.03.2019.

3. Release of the above grant is subject to the following conditions:

- (i) The grant will be utilized in accordance with the approved guidelines for the implementation of the Scheme.
- (ii) **Sharing pattern between the Central Government and the State Government is 90:10, in terms of the Ministry's OM letter No. G-24011/4/2015-UPA FTS: 13027 dated 2<sup>nd</sup> February, 2016.**
- (iii) The funds will be utilized for the purpose for which they are sanctioned. Otherwise funds will have to be refunded along with interest as per the provisions of GFR-2017.
- (iv) **Separate Utilization Certificates should be submitted for each sanction, for speedy reconciliation of the accounts.**
- (v) Progress of the scheme will be updated on DAY-NULM MIS portal on time.

4. Keeping in view the guidelines on **Funding Pattern and Financial Process** contained in Mission Document of DAY-NULM, States/UTs are required to allocate the funds components-wise and intimate the same to the Ministry. Such Component-wise allocation would deem to be approved by the Ministry. **Any subsequent change in the inter-se allocation among the different components can be done with the prior approval of the Ministry.**
5. It is certified that no Utilization Certificate in respect of the State Government is pending.
6. The expenditure involved is debitible under Major Head – 3601 – Grants-in-aid to State Govts. — 06– Centrally Sponsored Schemes Sub-major Head -101- central assistance share (Minor Head) – 32- National Urban Livelihoods Mission (NULM) – **32-01 Assistance to Non-NE States** - 32.01.31- Grants-in-aid-General under Demand No.56 – Ministry of Housing & Urban Poverty Alleviation for the year 2019-2020.
7. The amount of **Rs 1,32,28,000/- (Rupees One crore thirty two lakh and twenty eight thousand only)** may be transferred to Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22-02-1977. Government of Himachal Pradesh may kindly transfer the same amount to **Implementing Agency of DAY-NULM.**
8. This issues with the concurrence of Finance Division vide their **Diary No. JS & FA's ID Note No. 7 dated 28.08.2019.** The funds are released in respect of recurring grants.
9. This Sanction has been registered at **SI.No. 60** of the Sanction Register of UPA Section for the year 2019-2020.
