Sir,
I am directed to convey the sanction of the President for the release of the **first & final instalment of grant-in-aid** amounting of **₹2,19,95,000/- (₹ Two crores nineteen Lakhs and ninety five thousands only)** to Government of Himachal Pradesh as assistance under the Plan Scheme of DAY-NULM for the year 2016-17 as per details below:-

2. Release of the above grant is subject to the following conditions:-

- (i) The grant will be utilized in accordance with the approved guidelines for the implementation of the Scheme.
- (ii) Provide the State Share in the sharing pattern of 90:10 between the Central Government and the State Government.
- (iii) The funds will be utilized for the purpose for which they are sanctioned. Otherwise funds will have to be refunded along with interest as per the provisions of GFR-2005.
- (iv) Monthly Progress Report (MPR) for the Scheme will be furnished on time.

3. It is certified that no Utilization Certificate in respect of the State Government is pending.

4. The expenditure involved is debitable under Major Head – 3601 – Grants-in-aid to State Govts. – 04.435 – Other General Economic Services-Urban Oriented Employment Programme (Minor Head) – 05- National Urban Livelihoods Mission (NULM) – **05-00 Assistance to State Govts.** - 05.00.31- Grants-in-aid-General (PLAN) under Demand No.50 – Ministry of Housing & Urban Poverty Alleviation for the year 2016-2017.



5. The amount of ₹2,19,95,000/- (₹ Two crores nineteen lakhs and ninety five thousands only) may be transferred to Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22-02-1977. The Government of Himachal Pradesh may kindly transfer the same amount to Implementing Agency of DAY-NULM.

6. This issues with the concurrence of Finance Division vide their Diary No. 41/US(IFD)/FD/2017 dated 03.02.2017. The funds are released in respect of recurring grants.
