**Subject: Release of Grants-in-aid (Central Assistance) to Government of Himachal Pradesh under Deendayal Antyodaya Yojana - National Urban Livelihood Mission (DAY-NULM) during 2024-25 - reg**

Sir,

I am directed to convey the sanction of the President for release of ₹ 73,20,000/- (₹ Seventy three lakhs twenty thousand only) to the State Government of Himachal Pradesh as Central Assistance under DAY-NULM for financial year 2024-25, detailed under:-

2. The allocation for the State Govt. of Himachal Pradesh for the year 2024-25 is ₹ 4.00 crore. Central Share funds to be released as ₹ 1.00 crore (General: ₹ 73,20,000/-, SCSP: ₹ 22,50,000/- and TSP: ₹ 4,30,000/-).

3. Release of the above grant is subject to the following conditions:-

- (i) 100% compliance of new guidelines for release of funds issued by Ministry of Finance OM dt 23.03.2021 and its subsequent orders.
- (ii) All interest and other earnings against Grant-in-aid released, should be mandatorily remitted to the Consolidated Fund of India immediately after finalization of accounts. Such advance will not be allowed to be adjusted against future releases.
- (iii) State Government shall transfer the Central share as well as the commensurate State share to the SNA account within 30 days of receipt of Central share. Delay beyond 30 days in transfer of Central share to the SNA account, interest at the rate of 7% per annum will be charged.
- (iv) The grant will be utilized in accordance with the provisions contained in DAY-NULM guidelines.
- (v) Fund sharing pattern between the Central Government and the State Government is 90:10, in terms of the Ministry's OM letter No. G-24011/4/2015-UPA FTS: 13027 dated 2nd February, 2016.
- (vi) The funds will be utilized for the purpose for which it is sanctioned. Otherwise, funds will have to be refunded along with interest accrued thereon as per the provisions of GFR-2017.



(vii) Separate Utilization Certificates as per prescribed format along with Utilization of corresponding State Share should be submitted for each sanction, for speedy reconciliation of the accounts. Progress of the scheme will be updated on DAY-NULM MIS portal on time.

4. As per provisions contained in mission document of DAY-NULM regarding fund sharing pattern and financial progress. States/UTs are required to inter-se allocate the fund components-wise and intimate the same to the Ministry. Such Component-wise allocation would deem to be approved by the Ministry. Any subsequent change in the inter-se allocation among the different components can be done with the prior approval of the Ministry.

5. The expenditure involved is debitible under Major Head – 3601 – Grants-in-aid to State Govts. – 06– Centrally Sponsored Schemes Sub-major Head -101- Central Assistance Share (Minor Head) – 32- National Urban Livelihoods Mission (NULM) – 32-01 Assistance to Non-NE States - 32.01.31- Grants-in-aid-General under Demand No. 60 – Ministry of Housing & Urban Affairs for the year 2024-25.

6. The amount may be transferred to Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22-02-1977. Government of Himachal Pradesh may kindly transfer the same amount to **Implementing Agency of DAY-NULM**.

7. This issues with the concurrence of Integrated Finance Division of the Ministry vide **JS & FA Note No. 13 dated 02.09.2024**. The funds are released in respect of recurring grants.

8. This Sanction has been registered at **Sl.No. 09** of the Sanction Register of NULM Division for the year 2024-25.
