

Rs.31,43,000/- (Rupees Thirty One Lac Forty Three Thousand only) to Government of Himachal Pradesh for procuring the items as per details given below to enable them to strengthen and reinforce their capabilities for combating illicit trafficking in Narcotic drugs and Psychotropic Substances.
