

The accounts will be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts office of the Ministry/Department, whenever the Institution or Central Government is called upon to do so.
