Subject: Grants –in-Aid (part) to **State Government of Himachal Pradesh** for I.T, Refurbishing and Job Fair in Employment exchange of Govt. of Himachal Pradesh under **National Career Service Project (Mission Mode Project for interlinking of Employment Exchanges 2018-2019 reg.**

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 80,87,650/- (Eighty Lakhs eighty seven thousand six hundred fifty)** as **Grants–in-Aid** to State Government of Himachal Pradesh for I.T. equipment comprising of Rs.34,29,200/- (Thirty four lakhs twenty nine thousand two hundred only) and Refurbishing having amount of Rs.46,58,450/- (Forty six lakhs fifty eight thousand four hundred fifty only) in interlinking of Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2018-2019.

2- The release of grant-in-aid **Rs. 80,87,650/- (Eighty Lakhs eighty seven thousand six hundred fifty only)** to **State Government of Himachal Pradesh** is subject to the following terms and conditions:
i. **State Government of Himachal Pradesh** shall strictly follow the guideline issued vide by DGE and other orders issued by DGE from time to time.
ii. **State Government of Himachal Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
iii. **State Government of Himachal Pradesh** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
iv. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
v. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Himachal Pradesh
vi. The State Government of Himachal Pradesh is requested to utilize the said amount as first installment.
The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2018-19 as mentioned below:

The amount of Rs. 80,87,650/- (Eighty Lakhs eighty seven thousand six hundred fifty only) may be transferred to State Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Himachal Pradesh may kindly transfer the amount to District Employment Officer, Employment Exchanges, and Himachal Pradesh

Certified that no Utilization Certificate is pending in respect of the State mentioned in the Sanction Order as per requirement as this is the first installment.
