Subject: Release of recurring grant-in-aid to Govt of Himachal Pradesh for running 138 Crèches under the National Crèche Scheme for the Children of Working Mothers for the Period 01.04.2018 to 31.03.2019 of FY 2018-19.

Madam/Sir,

I am directed to convey the sanction of President of India to the payment of **Rs. 74,96,281/- (Rupees Seventy Four Lakhs Ninety Six Thousand Two Hundred Eighty One only) to the State Govt. of Himachal Pradesh for 1st, 2nd, 3rd & 4th quarter of 2018-19) as grant-in-aid (80% Govt's share) for running 138 crèches under National Crèche Scheme for Children of Working Mothers .**

2. It is also authorized to utilize the unspent balance amounting to Rs 92, 40,359/- available with the State Government at the end of FY 2017-18 in the Current FY 2018-19. Total Grant comes to Rs 74,96,281/- (16736640 –9240359) after adjusting the unspent balance.


3. The fund sharing pattern among the Central Government, State Government and organization/institution running the crèches will be in the ratio 80:10:10 and sanction of funds is subject to the following conditions:

- i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- ii. The States/UTs/NGOs shall also be required to contribute their share for implementation of the National Crèche Scheme.
- iii. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

4. The grant is further subject to condition that the State Govt. will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

5. Details of progress of expenditure on National Crèche Scheme from 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

6. The expenditure of **Rs. 74,96,281/- (Rupees Seventy Four Lakhs Ninety Six Thousand**
