The account shall be open to inspection by the Sanctioning Authority and audit, both by the Comptroller and Auditor General of India and internal audit by the Principal Accounts Office of the Ministry of Mines, whenever the Organization is called upon to do so.
- **5.** In the present case, the payment to be made to the State Governments is incentive in the form of Grant-in-aid (General). The agency has to furnish the Utilisation Certificate as per the procedure prescribed in GFR, 2017 and upload the same on PFMS Module against this sanction order.
- 6. Shri Arun Kumar Chail, Section Officer in the Ministry will be the Drawing and Disbursing Officer for this purpose. It is requested that the payment of ₹60,00,000/-(₹Sixty Lakh only) may kindly be made to concerned State Government as per details below:

Subject: Incentive to the State Governments from National Mineral Exploration Trust-reg.

To encourage the State Governments to auction more blocks, a one time incentive scheme of ₹20 Lakhs from the NMET funds for each mineral rich State with potential mineral blocks was introduced by the Ministry of Mines.

- 2. In this regard, NMET vide letter No. F.No.4/4/2021-NMET/179 dated $2^{t}9$ December, 2021 has circulated the following guidelines, as approved by the Hon'ble Minister of Mines and Chairman of the Governing body of NMET (Pg.72/c).
 - A sum of ₹ 20 Lakh will be released to each State (where mineral blocks are available for auction) for financial year 2021-22.
 - ii. ₹20 Lakh incentive or each successful auction of mineral block by the State Government.
 - iii. 50% of amount paid to Transaction Advisor, Subject to a maximum of ₹ 5 Lakh for each block which was put up for auction but could not be successfully auctioned.
 - iv. The reimbursement/incentive will be made for mineral block, auctioned or put up for auction but could not be auctioned, from 01.04.2021 onwards.
- 3. The Mines-IV Section has provided the list of following States which had potential blocks for auction during the financial year 2021-22(Pg. no. 74/c). The Incentive payment was made to the 13 States during the year 2021-22. Now, the payment is to be made to further 6 State Governments along with State Government of Goa (Pg. no. 75/c) in respect of their eligibility for the year 2021-22. The details of 7 State Governments for making payment of incentive is as under:
