I am directed to convey the sanction of the President for the payment of a sum of Rs. 9,00,00,000/- (Rupees nine crore only) as First installment for establishing three (3) new Nursing Colleges during the year 2023-24 at the rate of 3.00 crore for nursing college under the scheme of Centrally Sponsored Scheme of 'Augmenting Nursing Education - Establishment of new Colleges of Nursing (CoN) in co-location with Medical Colleges as follows:-

2. The above mentioned amount represents the First installment of Non-recurring grant-in-aid of Central Share for setting up of New Nursing Colleges.

3. The grant-in-aid is subject to the following:-

- The grant-in-aid should be utilized for the purpose for which it has been sanctioned.
- The grant-in-aid is subject to the conditions and principles laid down in Rule 228 to 245 of the General Financial Rules, 2017 and Instructions there under, modified from time to time as well as other specific condition that may be circulated from time to time.
- The accounts of the grantee institution/organization shall be open to inspection by the sanctioning authority and audit both by the Comptroller and Auditor General of India under the provision of the CAG (DPC) Act, 1971 and internal audit by chief controller of accounts of the Ministry, whenever the institution is called upon to do it.

- (iv) The grantee institution is not authorized to divert the grant or entrust the execution of the scheme for which the grant is made for another purpose. In case of it not being in a position to execute or complete the assignment, it should forthwith refund to the Central Government the entire amount of the grant received by it.
- (v) The State Government would furnish utilization certificate to the Central Government of the installments and also ensure that it has released its share under the scheme.
- (vi) The State Government must ensure proper implementation of the Memorandum of Understanding (MoU) signed by it with the Central Government under the Scheme.
- (vii) The State must ensure strict compliance of revised procedure for release of funds under the Centrally Sponsored Scheme (CSS) and monitoring utilization of the funds released as mentioned in the DoE, MoF OM No. 1(13)PFMS/FCI, 2020 dated 23.03.2021.
- (viii) The amount of Rs.9,00,00,000/- (Rupees nine crore only) shall be transferred to State Government through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II(45/76/SC) dated 22.02.1977.
- (ix) The expenditure involved will be met from Demand No. 901- Appropriation from Contingency Fund of India under Major Head '8000'-Contingency Fund (Major Head), 00-Sub-major head, 201-(Minor Head)-Appropriation from Consolidated Fund, 00-Sub Head, 00-Detailed Head, 00-Object Head 2023-24.
- (x) These issues with the approval of the concurrence of IFD vide their Concurrence Dairy No. CD-3094 dated 19.01.2024.
