

OFFICE MEMORANDUM

Subject:- Grant of additional increment on completion of 15, 20 and 25 years of service to drivers instead of 2 additional increments.

In supersession of this Department's Office Memorandum of even number dated 7.4.2012, the undersigned is directed to say that the matter regarding sanctioning of financial benefits to the Drivers of the State Government was under consideration of the State Government. After due consideration, it has been decided that the additional increment(s) will be granted to the Drivers on the following terms and conditions:-

- i) The drivers working in various government departments, on completion of 15, 20 and 25 years of regular service shall be allowed one increment each on completion of said years of service, w.e.f. 1.10.2022.
- ii) Those drivers, who have completed 15 to 20 years of service shall be granted one additional increment w.e.f. 1.10.2022 prospectively.
- iii) In case of drivers who have already been granted two additional increments after completion of 20 (twenty) years service before issuance of these orders, they may be granted one additional increment on completion of 25 years of service, prospectively.

- iv) The benefit of additional increments will be admissible only to drivers who have not got any promotion in any office/department, prior to completion of 15, 20 and 25 years of continuous regular service, as the case may be. Drivers who avail promotion prior to the period of 15 years, 20 years or 25 years of service as the case may be, will not be entitled to additional increment(s) allowed by this order.

Above decision may kindly be brought to the notice of all concerned for implementation in letter and spirit.
