Reimbursement of Expenditure incurred by the State Government of Himachal Pradesh for operating of Helicopter Services of M/s. Pawan Hans Helicopters Limited in Himachal Pradesh.

Sir,

I am directed to refer to Govt. of Himachal Pradesh's letter No. GAD-A(F)4-3/2018 dated 18.05.2020 for reimbursement of claim on account of Subsidized Helicopter Service for the months from December, 2019 to March, 2020.

- 2. The Audit team of DG Audit (Central Exp.), while conducting the audit of the Scheme during the period 2017-18, pointed out that as per scheme guidelines, Govt. of India will subsidize only the cost towards actual number of entitled passengers utilizing the helicopter services. No subsidy will be provided for the vacant seats.
- 3. The reimbursement claim bills submitted by Govt. of HP for the months of December, 2019 to March, 2020 have been examined in the light of the audit observation and accordingly revised statement has been prepared and is annexed **as Annex-I.**
- 4. A sanction of the competent authority is hereby conveyed for the release of a sum Rs. 1,62,33,842/- (Rupees One Crore Sixty Two Lakh Thirty Three Thousand Eight Hundred Forty Two Only) to the Secretary(GAD) to the Government of Himachal Pradesh, Shimla-2 as reimbursement of claims for helicopter services utilized by Govt. of Himachal Pradesh towards 75% share of Government of India, for the month of December, 2019 to March, 2020.

- 5. After adjustment of excess amount of Rs. 1,34,92,711/- made to Govt. of HP, the remaining admissible claim of Rs.27,41,131/- (Rupees Twenty Seven Lakh Forty One Thousand One Hundred Thirty One Only) may be released to the Secretary (GAD) to the Government of Himachal Pradesh, Shimla -2. The amount is debitable to Major Head-3601-Grants-in-aid to State Governments-08-Other Transfer-111-Special Assistance-02-Other Administrative Grants-02.06-Payment for Helicopter Services in J&K and HP-02.06.31-Grants-in-aid General under Demand No. 46 during the year 2020-2021.
- 6. It is requested that the amount of Rs.27,41,131/- may be released through RBI advice.
- 7. The State Government is advised to ensure compliance of all terms and conditions stipulated in this Ministry from time to time.
- 8. Excess payment if any is subject to due audit as per rule 238(3) of GFR-2017.
- 9. This issues with the concurrence of Integrated Finance Division, MHA vide their Dy. No. CF-3401661 dated 28.08.2020 and approval of competent authority.
- 10. The Sanction Order of even number dated 02.09.2020 on the subject may please be treated as withdrawn.
