In continuation of the (i) letter no. 1-5/2018-PP dated 22.02.2019 and 27.03.2019 sanctioning the first instalment of funds of Rs. 8,40,000/- (Rs. 4,20,000 vide letter dated 22.02.2019 and Rs. 4,20,000/- vide letter dated 27.03.2019) (ii) letter no. 1-5/2018-PP (Vol.II) dated 15.05.2020 sanctioning the second instalment of funds of Rs.8,40,000/- and (iii) letter no. 1-5/2018-PP (Vol.II) dated 30.03.2021 sanctioning Rs.7,00,000/- as part payment of third instalment of funds to Government of Himachal Pradesh under the Scheme 'Strengthening of District Disaster Management Authorities (DDMAs) of Hazard Prone Districts out of the 115 identified backward districts', I am directed to convey sanction of the competent authority for release of Rs.1,40,000 (Rupees One Lakh Forty Thousand Only) to State Government of Himachal Pradesh as remaining amount of third instalment for implementation of the Scheme - 'Strengthening of District Disaster Management Authorities (DDMAs) of Hazard Prone Districts out of the 115 identified backward districts'.
