Sir,

I am directed to refer to letter / order No.38-45/2013-NDM II dated 02.02.2015, 12.10.2015 & 16.02.2017 and to convey sanction of the competent authority to release of an amount of **Rs. 37,48,566/- (Rupees Thirty Seven Lakh Forty-Eight Thousand Five Hundred and Sixty-Six Only)** to the Government of Himachal Pradesh for implementation of the scheme 'Strengthening of SDMAs and DDMAs' during 2017-18. As, an amount of Rs. 12,51,434/- is already available with them as on 31.03.2017 from the previous release made to them, the total available amount for 2017-18 will be Rs. 50,00,000/-. Rs. 36 lakh may be utilized for payment of salary to DM professional and Rs. 14 lakh towards Administrative cost.




