Subject: Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) – Release of Funds (General Category) as 1st Instalment for the 100 clusters to the Government of Himachal Pradesh during 2017-18 – reg.

Sir,

I am directed to refer to this Department's letter No.2-1/2017- Org. Fmg dated 25th April, 2017 conveying the Administrative Approval for implementation of Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) and to convey the sanction of the President for release of an amount of **Rs. 218.4334 lakh** (Two crore Eighteen lakh Forty three Thousand Three Hundred Forty Rupees only) for **General category** as 1st Instalment of funds to **Government of Himachal Pradesh** for implementation of the **Paramparagat Krishi Vikas Yojana (PKVY)** scheme during 2017-18 as per the following details:

2. The amount for **Rs. 218.4334 lakh** will be debited to the following Major Head under Demand No.1 Agriculture, Cooperation & Farmers Welfare during the year 2017-18:-

3601 - Grant in aid to State Government (Major Head)
06 – Central Sponsored Scheme (Sub-Major Head)
101 – Central Assistance/Share (Minor Head)
43 – Green Revolution-Krishonnati Yojana
06 - Paramparagat Krishi Vikas Yojana
430631- Grants-in-aid-General

3. The expenditure to be incurred is subject to the following terms and conditions:-

(i) The grant shall be utilized by the concerned implementing agency in accordance with the operational guidelines of the scheme namely (guidelines already circulated to States and are also available at DAC website: www.agricoop.nic.in).

- (ii) Financial Assistance for various components shall be allowed as per cost norms in the operational guidelines of PKVY scheme on 90:10 sharing pattern between Government of India and State Government.
- (iii) The above mentioned amount is for the 1st year activities of 100 clusters.
- (iv) The expenditure is to be incurred for the PKVY components as per the PKVY guidelines issued vide dated 10.10.2015.
- (v) The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of Audited accounts and utilization certificate to this Department as soon as possible along with progress report after close of the financial year. The implementing agency shall furnish quarterly progress report regularly with details of physical and financial target and achievement. They will also be responsible to monitor utilization of funds for Women beneficiaries and maintain database of the same.
- (vi) The accounts of the implementing agency shall be open to Internal Audit of the Principal Accounts Officer, Department of Agriculture and Cooperation as well as Statutory Audit by the Comptroller and Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
- (vii) Interest earned and unspent funds will be added to PKVY Scheme fund for utilization for the approved activities of the Scheme.
- (viii) Revalidated amount of interest earned and unspent fund will be adjusted against future releases of first/second instalment and allocation of current financial year will be reduced to that extent.
4. This has been noted at S. No 50 of Register of grant of Financial Year 2017-18 as per GFR 212 (4) (b).
5. This sanction issues with the approval of Integrated Finance Division vide their Dy. No. 37189/FTS/AS&FA dated 13.09.2017.
