Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 60.8634 lakh** (Sixty lakh Eighty-Six Thousand Three Hundred Forty Rupees only) for **SC category** for 2nd year activities of 75 new clusters (20 ha each) to the Government of Himachal Pradesh for implementation of the **Paramparagat Krishi Vikas Yojana (PKVY)** scheme during 2020-21 as per the following details:

2. The amount for **Rs. 60.8634 lakh** will be debited to the following Major Head under Demand No.1 Agriculture, Cooperation & Farmers Welfare during the year 2020-21: -

- 3601 - Grant in aid to State Government (Major Head)
- 06 - Central Sponsored Scheme (Sub-Major Head)
- 789 - Special Component Plan for Scheduled Castes (Minor Heads)
- 39 - Green Revolution-Krishonnati Yojana
- 04 - Paramparagat Krishi Vikas Yojana
- 390431 - Grants-in-aid-General

3. The expenditure to be incurred is subject to the following terms and conditions:-

- (i) The grant shall be utilized by the concerned implementing agency in accordance with the new operational guidelines of the scheme namely (guidelines already circulated to States and are also available at DAC website: www.agricoop.nic.in).
- (ii) Financial Assistance for various components shall be allowed as per cost norms in the new operational guidelines of PKVY scheme on 90:10 sharing pattern between Government of India and State Government.

- (iii) The implementing State shall submit the Utilization Certificate (UC) according to the rule no 239 of the GFR -2017 in the format 12(C) and submit their UC through PFMS portal.
- (iv) Programme Division verify the Expenditure from the EAT (Expenditure Advance Transfer) module from PFMS. The UC not supported by the EAT module data is likely to be rejected & expenditure is not to be treated as regular. The agency should be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms & conditions of this sanction order.
- (v) The above mentioned amount is for the 2nd year activities of 75 new clusters (20 ha each) to the Government of Himachal Pradesh for implementation of the Paramparagat Krishi Vikas Yojana (PKVY) scheme during 2020-21.
- (vi) The expenditure is to be incurred for the PKVY components as per the New PKVY guidelines issued vide dated 25.10.2018.
- (vii) The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of Audited accounts and utilization certificate to this Department as soon as possible along with progress report after close of the financial year. The implementing agency shall furnish quarterly progress report regularly with details of physical and financial target and achievement. They will also be responsible to monitor utilization of funds for SC/ST/Women beneficiaries and maintain database of the same.
- (viii) The accounts of the implementing agency shall be open to Internal Audit of the Principal Accounts Officer, Department of Agriculture and Cooperation as well as Statutory Audit by the Comptroller and Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
- (ix) Interest earned and unspent funds will be added to PKVY Scheme fund for utilization for the approved activities of the Scheme.
- (x) Revalidated amount of interest earned and unspent fund will be adjusted against future releases of first/second instalment and allocation of current financial year will be reduced to that extent.
