2. The expenditure is debitable to Demand No. 93 Major Head '2225' Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities, 01 Welfare of Scheduled Castes (Sub Major Head), 789 Special Component Plan for Scheduled Castes (Minor Head), 29.00 Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PMAJAY) (Sub Head), 29.00.50 Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PMAJAY), Other Charges, under demand No. 93 of Ministry of Social Justice & Empowerment for the year 2022-23.
3. Arrangements may please be made to credit this amount to State Government in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2(45)/76 Special Cell, dated 30.8.1976, as modified vide O.M. of even number dated 16.09.1976 under intimation to us.
4. The sanction of the above Central Assistance amounting to **Rs.10.00 lakh** will be utilized by the concerned districts only for public purposes especially for livelihood support, asset creation, civic amenities creation & maintenance and bridging the gaps in the funds received from Union/State Government/UT Administration for various projects in the said districts.
5. The Central Assistance shall be utilized only as per the provisions contained in the guidelines of Awards for best performing districts.
6. The State Government will furnish an UC (in GFR 12-C format) indicating transfer of award amount to awardee district within 15 days.
7. As per the instructions contained in Ministry of Finance, Department of Expenditure's Circular No. 7 (1) E. Coord/2008 dated 5.6.2008, no amount shall be released to any State which has defaulted in furnishing Utilization Certificates for grants-in aid release by the Central
