

**Subject: Payment to the State Government of Himachal Pradesh for reimbursement of cost for organizing the Regional Workshop for Northern Region under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) during 21<sup>st</sup> & 22<sup>nd</sup> April, 2022 at Dharamshala, Himachal Pradesh- Reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of grants-in-aid amounting to **Rs. 25,71,842/- (Rupees Twenty Five Lakh Seventy One Thousand Eight Hundred Forty Two Only)** to the State Government of Himachal Pradesh for organisation of the Regional Rural Workshop for Northern Region under PMAY-G during 21<sup>st</sup> & 22<sup>nd</sup> April, 2022 at Dharamshala, Himachal Pradesh.

2. **The State Government will transfer the funds received in its account in the RBI to the concerned Single Nodal Account of PMAY-G within a period of 21 days of its receipt. These funds shall not be diverted to the Personal Deposit (PD) account or any other account by the State Government.** The funds shall also not be diverted to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/ Corporate Liquid Term Deposit (CLTD) Account etc. The factum of release of these funds must be registered in the Public Financial Management System (PFMS) through updation in relevant reports on PFMS.

4. This payment is made against the duly verified bills submitted by the State Government & examined in consultation with the Integrated Finance Division (IFD) of the Ministry.

5. The expenditure is debitable to the following Head of Account under Demand Number **87** of the Department of Rural Development (2022-23):

- 3601 – Grants-in-aid to State Governments (Major Head)
- 06 – Centrally Sponsored Schemes
- 101- Central Assistance/Share
- 25- Pradhan Mantri Awaas Yojana-Rural
- 25.02- Pradhan Mantri Awaas Yojana
- 25.02.35- Grants for creation of Capital Assets

6. The DDO, (PMAY-G), (DDO No. 208138) Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned will be transferred to the State Government of Himachal Pradesh.

7. **The accounts of all grantee institutions or organizations shall be open to Audit both by the Comptroller and Auditor General of India as well as by the Internal Audit wing of the Principal**

Accounts office of the Ministry of Rural Development/ Department functioning under Chief Controller of Accounts, in terms of Rule 236 of General Financial Rules, 2017.

8. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O. No. 207/Finance/2022-23 dated 08.07.2022.
