Subject: Pradhan Mantri Awaas Yojana (Gramin)- Release of 1stTranche of 2ndinstallment (excluding Admin cost) of Central Assistance for the year 2024-25 to the State of Himachal Pradesh- reg.

Madam/Sir,

I am directed to convey the administrative approval of the President of India to the payment of grants-in-aid amounting to **Rs. 288,93,25,000/- (Rupees Two Hundred Eighty Eight Crore Ninety Three Lakh and Twenty Five Thousand Only)** to the State of Himachal Pradesh as **1stTranche of 2ndinstallment** of Central Assistance for the year 2024-25 for the implementation of the Pradhan Mantri Awaas Yojana- Gramin in the State of Himachal Pradesh as per following details:-

2. The grant is towards the Revenue expenditure and shall be utilized for the construction of new houses subject to the conditions laid down in the framework for implementation under the Pradhan Mantri Awaas Yojana - Gramin and extant instructions issued from time to time. No deviation from the provisions of the Framework for Implementation of PMAY-G is permissible.
3. The expenditure on the implementation of the programme will be shared in the ratio of 90:10 between the Centre and the State.
4. It is reiterated that while allocating targets to Districts, the State/UT should follow the formula prescribed by the Ministry. It is clarified that earmarked Targets for SC, ST, and Minority cannot be diverted to the General category. Only SC and ST targets can be interchanged if there are sufficient justifications.
5. **The State/UT Government will transfer the Central share received in its account in the RBI to the concerned State Nodal Account (SNA) within a period of 30 days of its receipt. The Central share shall not be diverted to the Personal Deposit (PD) account or any other**

account by the State Government. The corresponding State share should be released as early as possible and not later than 30 days after the release of the Central share. The funds will be maintained in the Single Nodal Account of PMAY-G and the State Government shall not transfer scheme-related funds to any other bank account, except for actual payments under PMAY-G. The funds shall also not be diverted to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/ Corporate Liquid Term Deposit (CLTD) Account etc. In case of a shortfall in State share, the corresponding amount of Central share will be deducted from the 2nd installment. The factum of the release of these funds must be registered in the Public Financial Management System (PFMS) through updation in the TRSY02 report. It may be ensured that the same is also reflected on AwaasSoft.

6. No Utilization Certificate is pending in respect of Pradhan Mantri Awaas Yojana-Gramin against the recipient organization for the previous year. Utilization Certificate of Indira Awaas Yojana prior to the financial year 2016-17 must be submitted by the State separately.

7. The expenditure is debitable to the following Head of Accounts under Demand No. 87, Department of Rural Development (2024-25).
