

Sir,

- 1.1. I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs. 171,25,00,000/- (Rupees One Hundred and Seventy One crore and Twenty Five Lakh only) to the State Government of Himachal Pradesh as 1st Tranche of 2nd installment of Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) during the Financial Year 2021-22.
- 1.2. The amount of **Rs. 171.25 crore** is adjusted towards balance payment of programme fund under Regular PMGSY as per the details given below:

2. The State Government shall transfer these funds along with the corresponding State share to Himachal Pradesh Gram Sadak Development Agency (HPGSDA) within a maximum period of 15 days from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be considered to stop further releases. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under;

- 3. Himachal Pradesh Gram Sadak Development Agency (HPGSDA) has nominated **Shri Bhawan Sharma** Engineer-in-Chief, Public Works Department, Himachal Pradesh, Shimla as the Empowered Officer.
- 4. The funds transferred by the State Government to HPGSDA shall be kept in a separate Saving Bank Account No. 3383000100123798 in Punjab National Bank, Near Comberemere Hotel, Shimla (Branch Code No.010211406 IFC Code No. PUNB0338300). It shall be ensured by Himachal Pradesh Gram Sadak Development Agency (HPGSDA) that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilised only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Himachal Pradesh Gram Sadak Development Agency (HPGSDA) shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

- The Empowered officer shall issue standing instructions to the Bank regarding the names of 5. Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.
- No Utilisation Certificate is pending from Himachal Pradesh Gram Sadak Development Agency 6. (HPGSDA).
- The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules.
