Subject: Release of 2nd Tranche of 2nd installment of Programme fund and 1st tranche of 1st installment of Admin fund to State of Himachal Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2022-23-reg.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 146,75,00,000/- (Rupees One Hundred Forty Six Crore and Seventy Five Lakh only)** to the State of Himachal Pradesh as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2022-23** as per the details given below:

*The State is required to release corresponding State Share of Rs 0.361 Crore against admin fund release.

1.2. The amount of **Rs. 143.50 crore** is adjusted towards balance payment of programme fund under Regular PMGSY as per the details given below:

2. **The State Government shall transfer these funds along with the corresponding State share to Himachal Pradesh Gram Sadak Development Agency (HPGSDA) within 30 days from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.** The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. Himachal Pradesh Gram Sadak Development Agency (HPGSDA) has nominated **Shri Bhawan Sharma** Engineer-in-Chief, Public Works Department, Himachal Pradesh, Shimla as the Empowered Officer.

4. The funds transferred by the State Government to HPGSDA shall be kept in a separate **Saving Bank Account No. 3383000100123798 in Punjab National Bank, Near Comberemere Hotel, Shimla (Branch Code No.010211406 IFC Code No. PUNB0338300)**. It shall be ensured by Himachal Pradesh Gram Sadak Development Agency (HPGSDA) that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilised only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Himachal Pradesh Gram Sadak Development Agency (HPGSDA) shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from Himachal Pradesh Gram Sadak Development Agency (HPGSDA).

7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

8. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in term of Rule 230(8) of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme- specific portals integrated with PFMS and in MIS provided by the banks.

9. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.

10. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.

11. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236(1)** of the General Financial Rules.

12. The expenditure is debit to the following Head of Accounts under **Demand No. 87** Department of Rural Development (2022-23):
