**Subject: Release of Additional installment of Annual Allocation 2018-19 to State Government of Himachal Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) -reg.**

Sir,

1.1. I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 90,00,00,000/- (Rupees Ninety Crore only )** to the State Government of Himachal Pradesh as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2018-19.

1.2. The amount of Rs. 90.00 crore is being adjusted towards balance payment of programme fund under World Bank-RRP-II as per the details given below:

1.3. The State Government must transfer these funds to Himachal Pradesh Gram Sadak Development Agency (HPGSDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

1.4. Himachal Pradesh Gram Sadak Development Agency (HPGSDA) has nominated **Shri R.P.Verma** Engineer-in-Chief, Public Works Department, Himachal Pradesh, Shimla as the Empowered Officer.

**1.5.** The funds transferred by the State Government to HPGSDA shall be kept in a separate Saving Bank Account No. 3383000100123798 in Punjab National Bank, Near Comberemere Hotel, Shimla (Branch Code No.010211406 IFC Code No. PUNB0338300). It shall be ensured by Himachal Pradesh Gram Sadak Development Agency (HPGSDA) that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilised only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Himachal Pradesh Gram Sadak Development Agency (HPGSDA) shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

**1.6.** The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

**1.7.** No Utilisation Certificate is pending from Himachal Pradesh Gram Sadak Development Agency (HPGSDA).

**1.8.** The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

**1.9.** The expenditure is debit to the following Head of Account under Demand No. 82 of the Department of Rural Development during the current financial year 2018-19:-

**1.10.** Secretariat of the Election Commission of India, New Delhi has stated that release of funds under PMGSY would be subject to the following conditions:-

(i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.

(ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.

(iii) These restrictions on publicity will be applicable to the Central Government as well as State Governments concerned.

(iv) The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.

(v) No new work shall be taken up afresh during MCC period.

1.11 The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1.1 above will be transferred to State Government of Himachal Pradesh.

1.12. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O. No.1379/Finance/2018-19, dated 19.03.2019.
