- 3. The State shall ensure that 10% of their share, based on the release of funds by the Govt. of India is credited to appropriate accounts, within one month.
- 4. The Grant-in-aid shall follow the terms and conditions contained in GFR-2017 and the instructions issued by the Govt. of India, as amended from time to time. The State Government shall not make any changes in the allocations or re-appropriations among different components/ activities without the approval of Ministry of Skill Development & Entrepreneurship, Govt. of India.
- 5. The State Government shall utilize the grants-in-aid in accordance with the list of activities **annexed** herewith and submit the actual Utilization Certificate of the grant within twelve months of the closure of the financial year in the prescribed GFR 12 C format along with the audited statement of accounts, expenditure statement, achievement-cumperformance report, other relevant documents as applicable and statement of fund position showing unspent balance, funds released as advance, interest earned on unspent balance as and when due and Taxation shall be applicable as per Laws. State Government will be under obligation to update progress status to this Ministry periodically.

6. The accounts of the grantee States shall be open to inspection by the sanctioning authority and audit both by the Comptroller and Auditor General of India and the internal

State Government shall send intimation regarding receipt of Grant-in-aid to Principal Accounts Officer, Ministry of Skill Development & Entrepreneurship, New Delhi.
- 8. There is no UC pending against the State pertaining to the State component for implementation of Centrally Sponsored Scheme SANKALP.
