I am directed to convey the sanction of the President for release of 1st and final installment of central share of Rs. **85,37,000/-(Rupees eighty five lakh thirty seven thousand only)** to the Government of Himachal Pradeshfor providing relief assistance to 3,557 nos fishers/fish farmers while implementation of the activity namely "Livelihood and nutritional support for socio economically backward, active traditional fishers' families for conservation of fisheries resources during fish ban/lean period" under the CSS on 'Pradhan Mantri Matsya Sampada Yojana (PMMSY): during the financial year 2021-22.

- 2. The Administrative Approval for implementation of 'Pradhan Mantri Matsya Sampada Yojana (PMMSY)' for 2021-22 has been notified vide this Ministry's letter No. J- 117012-1/2020-Fy dated 3rd May, 2021.
- 3. The consolidated Administrative Approval of Government of India to the proposal of 11 States/ UTs including Government of Himachal Pradeshfor implementation of the activity namely "Livelihood and nutritional support for socio economically backward, active traditional fishers' families for conservation of fisheries resources during fish ban/lean period" in the country under the PMMSY has been notified vide this Ministry's order of even number dated 12^h September, 2021.
 - 4. The Government of Himachal Pradesh shall ensure compliance of the terms and conditions stipulated in the approvals mentioned in para-2 and para-3 above.
 - 5. The release of central funds is subject to the following terms and conditions:
 - a. The sanction of aforementioned amount will be governed by the provisions of the General Financial Rules (GFR), 2017 as amended from time-to-time.
 - b. The Government of Himachal Pradesh will utilize the funds for the purpose for which it has been released. The State Government will furnish progress report indicating physical and financial achievement on quarterly basis till the project is completed in all respects.
 - c. The Government of Himachal Pradesh will furnish Utilization Certificate (UC) as per prescribed proforma under GFR-2017 in respect of the central grant released and utilized for implementation of the approved project.
 - d. The accounts regarding release of funds and their utilization shall be open to inspection by the Sanctioning Authority and Audit, both by the Comptroller & Auditor General of India and internal audit of the Principal Accounts Office of this Ministry.
 - The Government of Himachal Pradesh will ensure transfer of benefit to beneficiaries directly to their accounts in electronic mode through DBT platform. The State Government will maintain the details of beneficiaries covered under the PMMSY indicating name, Aadhaar number and mobile number, account number, fund transferred etc., and furnish the same as and when required to the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying.
