Subject: Proposal for release of grant of administrative expenses to the State Government of Himachal Pradesh under Post-matric Scholarship Scheme for the financial year 2015-16, 2016-17 & 2017-18 during 2017-18.

I am directed to convey the sanction of the President for release of recurring grant-in-aid of ₹ **2,45,556/- (Rupees Two Lakh Forty Five Thousand Five Hundred Fifty Six Only)** as 100% Central Share to the Government of Himachal Pradesh, for implementation of the Scheme of Post-matric scholarship for students belonging to the minority communities, for the financial year 2015-16, 2016-17 & 2017-18 during 2017-18 for the purpose of Administrative Expenses.

2. The recurring grant may be released to the Government of Himachal Pradesh through CAS, Reserve Bank of India, Nagpur.

Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within three months' time i.e. 31.08.2017 as the financial year 2016-17 is already over. It is also to be certified by the grantee that no utilization certificate is pending in respect of previous grant/grants.
