Central Assistance being released is adjustable against the final due Central Assistance for the Current Financial Year. The release of fund is subject to the following conditions:

(i) Furnishing the Audited Statement of Accounts and the Utilization Certificate as per the GFR 12C in respect of the Grant-in-Aid released during 2023-24, duly signed by authorized signatory and counter signed by Administrative Secretary of the State Government.

- (ii) Furnishing the details of District-wise number of beneficiaries, class-wise, genderwise (boys and girls) and institution-wise covered under the scheme for the last year as well as during the current year separately.
- 6. In the event of failure on the part of the State Government to utilize the Grant-in-Aid for the purpose for which it has been sanctioned or failure to comply with the conditions of this sanction, the State Government shall be liable to refund, the whole or part of the amount, as the case may be, in terms of Rule 209(6)(ix) of GFRs.
- 7. The State Government will maintain separate accounts in respect of the Central Assistance received for this Scheme. The State Government will have the accounts of the Central Assistance audited either by the Government Auditor and shall furnish the Utilization Certificate on the prescribed format i.e. GFR-12C in original duly signed by authorized signatory of the State Government and counter signed by the Administrative Secretary of the Division regulating the scheme as per Rule 239 of GFR 2017, to this Ministry.
- 8. The accounts will be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts office of the Ministry/Department, whenever the Institution or Central Government is called upon to do so.
- 9. Further, as per the decision of the Government of India, the scholarship amount due to the selected beneficiaries (students) shall be disbursed through DBT mode only. Other mode of disbursement such as through cash or cheque shall be unacceptable.
- 10. The scholarship will be disbursed as per Gazette Notification dated 16.02.2017 issued under the provision of Section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016.
