
2. The recurring grant may be released to the Government of Himachal Pradesh through CAS, Reserve Bank of India, Nagpur.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within three months' time as the financial year 2018-19 is already over. It is also to be certified by the grantee that no utilization certificate is pending in respect of previous grant/grants.


