I am directed to convey the sanction of the President for release of **Rs. 1,02,00,000/- (Rupees- One Crore Two Lakhs only)** to the State Government of **Himachal Pradesh** during the current financial year i.e. **2020-21** under Centrally sponsored Scheme of Pre-Matric Scholarship to the Students studying in class IX and X belonging to Scheduled Castes, as per calculation sheet annexed.


2. The expenditure is debitable to the **Major Head-3601- Welfare of Scheduled Castes, Scheduled Tribes, Other backward Classes and Minorities, 06 Welfare of Scheduled Castes (Minor head) (Major Sub Head), 789 - Special component Plan for Scheduled Castes (Minor head) 34 Pre-Matric Scholarship Scheme for Scheduled Castes (Sub Head) 02- Detailed Head 31-Grants -in -aid General under Demand No. 92 of Ministry of Social Justice and Empowerment for the year 2020-21.**

3. It is requested that arrangements may kindly be made to credit this amount to the **State Government of Himachal Pradesh** in accordance with the procedure laid down in the Ministry of Finance O.M. No. 2 (45)76-Spl.Cell dated 30.08.76 as modified vide their O.M. of even number dated 16.09.76, under intimation to this Ministry.

4. This sanction issues with the concurrence of the Integrated finance Division vide their **Note No. 52 dated 27/11/2020.**

5. The payee has no Utilization Certificate as due for rendition under the rules under this scheme of the Ministry.


the representatives of the officers from the office of Comptroller and Auditor General of India/Government of India. The State Government will have the accounts of the grants-in-aid audited by the Govt. Auditor and shall furnish the Utilization Certificate in the prescribed format in **GFR-12C** in original duly signed by authorized signatory of the State Govt.

7. State Government may ensure the release of scholarship as per the revised guidelines of Pre-Matric Scholarship for SC students studying in class IX and X issued by this Department vide letter no 11011/03/2019-SCD-V dated 06/09/2019. State Government may ensure that Central Assistance released from this department may not park in the State Treasury and the same is fully utilized by the SNAs as per regulation of this scheme.

8. The accounts will be open to inspection by the sanctioning authority and audit, both the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department whenever the State Govt. is called upon to do so.


