I am directed to convey the sanction of the President to the release of an amount of Rs. 143.01 lakh (Rupees One crore forty three lakh one thousand only) under the Scheme of Pre-matric Scholarship for Scheduled Caste Students during 2017-18.

2. The expenditure is debit to the Major Head 3601 - Welfare of Scheduled Castes, Scheduled Tribes, Other Backward classes and Minorities, 06 Welfare of Scheduled Castes (Major Sub Head), 789-Special Component Plan for Schedule Castes (Minor Head) 34 Pre-matric Scholarship Scheme for Scheduled Castes (Sub Head) 02- detailed head 31-Grant-in-aid General under demand No 89 of Ministry of Social Justice & Empowerment for the year 2017-18. As per re-appropriation order dated 02/11/2017, the budget allocation of RS 17.00 Crore for DBT Head has been re-appropriated to Non-DBT Head to State (3601).

3. It is requested that arrangement may kindly be made to credit this amount to the State Governments/UTs in accordance with the procedure laid down in the Ministry of Finance vide their O.M.No.2(45) 76-Spl.Cell dated 30.08.1976 as modified vide their O.M. even number dated 16.9.1976 under intimation to this Ministry.

4. This sanction issues with the concurrence of the Integrated Finance Division vide their Dy.No.21251/JS&FA dated 22.02.2018.

5. The payee has no Utilization Certificate as due for rendition under the Rule under this scheme of the Ministry.

6. The State Government will maintain separate accounts in respect of the grant-in-aid received under the scheme. The accounts will remain open for inspection by the representatives of the officers from the Office of Comptroller and Auditor General of India/Government of India The State Govt. will have the accounts of the grant-in-aid audited by the Govt. Auditor and shall furnish the Utilization Certificate in the prescribed format in GFR-12-C in original duly signed by authorized signatory of the State Govt.
