Sub: Release of Central Assistance on *ad hoc* basis to the State Government of Himachal Pradesh (Social Justice and Empowerment Department) under the Centrally Sponsored Scheme for Implementation of the Protection of Civil Rights Act, 1955 and the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 during 2020-21.

Sir,

I am directed to convey the sanction of the Competent Authority for payment of Rs.27,61,194/- (Rupees Twenty Seven Lakhs Sixty One Thousand One Hundred Ninety four Only) to the State Government of Himachal Pradesh on *ad hoc basis as 1st installment*, during the year 2020-21, towards implementation of the Scheme under the Protection of Civil Rights Act, 1955 and the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989.


2. The aforesaid ad hoc amount released is subject to adjustment at the time of releasing further installments of Central assistance on the basis of specific proposal received from the State Government for the year 2020-21.

3. In view of the importance attached to the Centrally Sponsored Scheme, it is emphasized that the State Government should not divert any part of the funds provided for this scheme, without the prior concurrence of the Government of India.

4. The State Government will maintain separate accounts in respect of the Central Assistance received for the Scheme. The account will remain open for inspection by the representatives or the officers from the office of Comptroller and Auditor General of India/Government of India at any time. The State Government will have the accounts of the Central Assistance audited either by the Government Auditor and shall furnish the Utilization Certificate on the prescribed format i.e. GFR 12-C (See Rule 239) of General Financial Rules 2017, in original duly signed by authorized signatory not below the level of Director of the State Government to this Ministry.

5. The accounts will be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Central Government is called upon to do so.
