Sub: Release of Grant-in-aid (Plan) to State Government of Himachal Pradesh under Rashtriya Swasthya Bima Yojana (RSBY) scheme from the SCSP category during the year 2017-18.

Sir,
I am directed to convey the sanction of the President of India to release **Rs.81,30,664/-**(Rupees Eighty One Lakhs Thirty Thousand Six Hundred and Sixty Four only) to the State Government of Himachal Pradesh towards Central Government's Share of Premium in respect of extension of policy period from 01.08.2017 to 31.03.2018 for 2,11,789 of smart cards of BPL families under Rashtriya Swasthya Bima Yojana to the State Government of Himachal Pradesh on the following terms and conditions:

- (i) Grant-in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in form **GFR 12C**) shall be furnished that the Contribution has been utilized for the purpose for which it was sanctioned.
- (ii) The accounts relating to this sanction shall be open to audit by the Comptroller and Auditor General of India or by the representatives from the Internal Audit of the Ministry and also for verification by Officers of the Ministry or State Government at any point of time.
- (iii) An audited statement of accounts (in duplicate) shall be furnished to this Ministry within **three months** of the expiry of the time prescribed for which Grant-in-aid was released.
- (iv) Utilization Certificate as per **Form 12 C of General Financial Rules** in respect of the total Grant-in-aid in a financial year shall be furnished to the Ministry by the State Government.
- (v) No part of the grant will be utilized for meeting administrative/establishment expenditure.
- (vi) The Government may lay down any other condition prior to the release of the Grant-in-aid.

2. The above expenditure involved will be met from Grant Number: 42 (Ministry of Health & Family Welfare) for the Financial Year 2017-18 as per details given below:

3. It is certified that Utilization Certificate for the financial year 2016-17 and Audit Report for the financial year 2015-16 have been received from the State Government of Himachal Pradesh.


4. The amount of **Rs.81,30,664/-**(Rupees Eighty One Lakhs Thirty Thousand Six Hundred and Sixty Four only) may be transferred to State Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977. District-wise and insurance company-wise details for release of premium under RSBY are given at Annexure.

5. The expenditure shall be incurred in respect of Plan heads of Accounts under the provision of GFR-2017/Receipts and Payments Rule 1983 and for the purpose for which it was sanctioned as clearly specified in para (1). The Sanction order is being issued accordance with Rule 228 to 245 of General Finance Rule (GFR)-2017.

6. It shall be the responsibility of the State Government of Himachal Pradesh and the SNA to exercise due diligence as per norms prescribed for scrutiny of the documents and accuracy of data before release of Central Government's Share of Premium to the Insurer. Any excess amount received towards Central Government's Share of Premium shall be refunded back to the Central Government.

7. This sanction is issued with the concurrence of Integrated Finance Division, which they have provided, vide their concurrence No. C-2438 dated 22.12.2017.


