Sub:- Release of Grants to Himachal Pradesh under the components of Multidisciplinary Education and Research Universities (MERU) and Grants to Strengthen Universities (GSU) under Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of Rs. 12,67,42,500/- (Rupees Twelve Crore Sixty Seven Lakhs Forty Two Thousand Five Hundred Only) as 1st installment of Multi-disciplinary Education and Research Universities (MERU) component to 1 University and 1st installment of Grants to Strengthen Universities (GSU) component to 1 University. The central: state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA). Under the initiative under reference, the Central Government shall provide assistance to the State/UT Governments for various components, which are mentioned as per the guidelines under PM-USHA.

- 2. The 1st installment of Multi-disciplinary Education and Research Universities (MERU) component to 1 University and 1st installment of Grants to Strengthen Universities (GSU) component to 1 University. The central:state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA) amounts to Rs. 12,67,42,500/- (Rupees Twelve Crore Sixty Seven Lakhs Forty Two Thousand Five Hundred Only). Further installments of the allocation shall be released by the Ministry only after the State/ UT Government concerned releases its committed share, besides submission of the Utilisation Certificate by the State/ UT in respect of the installment of the Central grant released.
- 3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State/ UT Government as well as Director, Higher Education of the State/ UT with a copy to the undersigned. The State will then transfer these amounts to the RUSA/ PM-USHA bank account of State.
- 5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Himachal Pradesh**. Further, the accounts of **Himachal Pradesh** in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Education, Department of Higher Education, whenever it is called upon to do so.
- 6. The amount shall be debited to the following three Heads of Demand No.26-Department of Higher Education:

The central: state share of 60:40 to be incurred to the Government of Himachal Pradesh, under PM-USHA.

The Expenditure Rs. 8,14,40,336/- (Rupees Eight Crore Fourteen Lakhs Forty Thousand Three Hundred and Thirty Six Only) will be debited to Demand No.26-Department of Higher Education from: Major Head 3601 Grants-in-aid to State Government, 06- Centrally Sponsored Schemes 101- Central Assistance/Share, 33-National Education Mission: Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 01-Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31-Grant in Aid General, of the financial year 2023-24.
