Sub:- Release of Grants to **Himachal Pradesh** as 1<sup>st</sup> installment for Upgradation of 1 Existing Colleges to Model Degree Colleges, 3<sup>rd</sup> installment for 1 Model Degree College, 3<sup>rd</sup> (final) installment for Infrastructure Grants to 2 Colleges, 6<sup>th</sup> (final) installment for Infrastructure Grants to 6 Colleges and final installment for Equity Initiative to 1 University & 21 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of Rs.7,34,08,340/- (Rupees Seven Crore Thirty Four Lakh Eight Thousand Three Hundred Forty Only) as 1<sup>st</sup> installment for Upgradation of 1 Existing Colleges to Model Degree Colleges, 3<sup>rd</sup> installment for 1 Model Degree College, 3<sup>rd</sup> (final) installment for Infrastructure Grants to 2 Colleges, 6<sup>th</sup> (final) installment for Infrastructure Grants to 6 Colleges and final installment for Equity Initiative to 1 University & 21 Colleges at the central: state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- 2. Under RUSA, the Central Government shall provide assistance to the extent of 90% to Special category states (NER, J&K, Uttarakhand and Himachal Pradesh). The fund being released are 1<sup>st</sup> installment for Upgradation of 1 Existing Colleges to Model Degree Colleges is Rs.1,80,00,000/-, 3<sup>rd</sup> installment for 1 Model Degree College is Rs.1,62,00,000/-, 3<sup>rd</sup> (final) installment for Infrastructure Grants to 2 Colleges is Rs.90,00,000/-, 6<sup>th</sup> (final) installment for Infrastructure Grants to 6 Colleges is Rs.1,08,00,000/- and final installment for Equity Initiative to 1 University is Rs.1,83,41,750/-& 21 Colleges is Rs.10,66,590/- at the central: state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). The subsequent releases will be dependent on the submission of Utilisation Certificate for the 75% utilization of the grants released.
- 3. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release Rs.7,34,08,340/- (Rupees Seven Crore Thirty Four Lakh Eight Thousand Three Hundred Forty Only) of the allocation as the respective installment. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

- 4. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.
- 5. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).
- 6. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Himachal Pradesh**. Further, the accounts of **Himachal Pradesh** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.
- 7. The amount is debitable to the following three Heads of Demand No.58-Department of Higher Education:

Accordingly, I am directed to convey the sanction of the President to release an amount of Rs.1,46,81,668/- (Rupees One Crore Forty Six Lakh Eighty One Thousand Six Hundred Sixty Eight Only) as the SC Component of the 1<sup>st</sup> installment for Upgradation of 1 Existing Colleges to Model Degree Colleges, 3<sup>rd</sup> installment for 1 Model Degree College, 3<sup>rd</sup> (final) installment for Infrastructure Grants to 2 Colleges, 6<sup>th</sup> (final) installment for Infrastructure Grants to 6 Colleges and final installment for Equity Initiative to 1 University & 21 Colleges at the central: state share of 90:10 to be incurred to the Government of Himachal Pradesh, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).
- 9. The Expenditure of Rs.1,46,81,668/- (Rupees One Crore Forty Six Lakh Eighty One Thousand Six Hundred Sixty Eight Only) will be debited to Demand No.58-Department of Higher Education from: Major Head 3601 Grants-in-aid to State Government, 06- Centrally Sponsored Schemes 789- Special Component Plan for Scheduled Castes, 33-National Education Mission: Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 03- Rashtriya Uchchatar Shiksha Abhiyan (RUSA) -MUSK, 31-Grants-in-aid-General, of the financial year 2019-20.
