Sub:- Release of Grants to **Himachal Pradesh** as Infrastructure to 23 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer the sanction of the President to release an amount of Rs.20,70,00,000/- (Rupees Twenty Crores Seventy Lakhs Only) as the 2nd installment to be incurred to the State Government of Himachal Pradesh as grants for Infrastructure to 23 Colleges under RUSA, out of total amount of central share of Rs.41,40,00,000/- (Rupees Forty One Crores Forty Lakhs Only) under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) for the 12th Plan period. Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- 2. Under RUSA, the Central Government shall provide assistance to the extent of 90% in Special Category States. Since **Himachal Pradesh** comes under the Special Category State, the ratio of Centre to State share in the grants is 90:10. The second installment is of the Centre share as grants for Infrastructure to 23 Colleges is **Rs.20,70,00,000/-**. The subsequent releases will be dependent on the submission of Utilisation Certificate for the 75% utilization of the grants released.
- 3. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release Rs.20,70,00,000/- (Rupees Twenty Crores Seventy Lakhs Only) of the allocation as the first installment. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the first installment of the grant released.

- 4. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.
- 5. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).
- 6. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Himachal Pradesh**. Further, the accounts of **Himachal Pradesh** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.
- 7. The amount is debitable to the following three Heads of Demand No.52-Department of Higher Education:

- 11. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.
