Subject :- **Minus balances/ overpayment of GPF at the time of Final
payment - Clarification regarding payment of leave
encashment.**

Sir/ Madam,


I am directed to invite a reference to this Department letter No. Fin (C) A(3) -5/2002 dated 12th November, 2008 vide which it was clarified that the bill for leave encashment of the retiree may be prepared by the Department on the receipt of final payment authority letter in respect of GPF, issued by the office of the Accountant General, so that any remaining overpayment could be recovered from the leave encashment.

2. This department is receiving references from various offices of the State Government seeking clarification with regard to the payment of leave encashment when the final payment of General Provident Fund has not been made to the retired Officer/ official. After reconsidering this matter in this Department, it is clarified further that if the concerned DDO is satisfied after obtaining the final "No Due Certificate" that there is no amount to be recovered from the retiree, the amount of leave encashment of the retiree can be released before the final payment of GPF amount subject to the condition that there should not be minus balances of GPF in his GPF account. This provision shall also be applicable in case a retiree retains his GPF accumulation with the State Government after the permissible period of six months as prescribed in the GPF rules.


