Subject: Amendment of instructions regarding reimbursement of room tariff for occupation of accommodation in Circuit House(s)/Rest House(s) except Circuit House Willy's Park and Peterhof, Shimla.

The undersigned is directed to refer to the Notification issued by the General Administration Department vide No. GAD-D-(G)6-1/2019-L dated 30th June, 2023 vide which the room tariff for occupation of accommodation in respect of Circuit House(s)/Rest House(s) except Circuit House Willy's Park and Peterhof, Shimla has been fixed. Consequent upon issuance of this Notification the Governor, Himachal Pradesh is pleased to order that the second proviso below Rule-5(I) as prescribed vide Office Memorandum of even number dated 7th June, 2023 shall be added as under:-

"Provided further that reimbursement of actual room tariff paid by the Government servant on duty, in respect of Circuit House(s)/Rest House(s) except Circuit House Willy's Park and Peterhof, Shimla, shall be reimbursed subject to production of self declaration by the concerned Govt. servant, of the tariff paid, the record of which shall be maintained by the concerned Circuit House/Rest House."

These orders will come into force with immediate effect.
