Sir,

The undersigned is directed to convey the sanction of the President of India to the payment of Rs. **81.28 Lakh (Rupees Eighty One Lakh Twenty Eight Thousand Only)** to the respective State Governments being the grant component of Additional Central Assistance for Externally Aided Projects payable in the year 2015-2016 under **Reimbursement Procedure on back to back basis(90% Grant)** as below:

2. The aforesaid releases is made on the basis of recommendations made by the O/o CAAA vide its letter no. AAAD/DISB.I/ACA B2B/033/2016000899-905 dated 08/06/2016. However, the balance amount of **Rs. 9.04 Lakh** (as mentioned at Sl. No.06 of the said letter) is being released vide Sanction No. **53(2)/PF-I/2016-539** dated 09.06.2016 being **10% Loan**.

3. The Payment may kindly be released to the State Governments immediately. (**State Government may release the funds to the project authorities within 7 days of receipt , failing which Government of India could claim interest on the undisbursed funds held with the State Government**).





