No. 01 of the said letter) is being released vide Sanction No. 53(2)/PF-I/2016-1049 dated 30.09.2016 being 10% Loan.

3. The Payment may kindly be released to the State Governments immediately. (State Government may release the funds to the project authorities within 7 days of receipt , failing which Government of India could claim interest on the undisbursed funds held with the State Government).




