The undersigned is directed to convey the sanction of the President of India to the payment of Rs. **176.76 Lakh ( Rupees One Crore Seventy Six Lakh Seventy Six Thousand Only)** to the respective State Governments being the grant component of Additional Central Assistance for Externally Aided Projects payable in the year 2016-2017 under **Reimbursement Procedure on back to back basis** as below: (Rs in lakh)

However, the balance amount of Rs 19.64 lakh (as mentioned at Sl. No. 08 of the said letter) is being released vide Sanction No. 53(2)/PF-I/2015-1550 dated 06.01.2017 being 10% Loan.

3. The Payment may kindly be released to the State Governments immediately. (State Government may release the funds to the project authorities within 7 days of receipt , failing which Government of India could claim interest on the undisbursed funds held with the State Government).




