The undersigned is directed to convey the sanction of the President of India to the payment of Rs. **92.57 Lakh (Rupees Ninety Two Lakh Fifty Seven Thousand Only)** to the respective State Governments being the grant component of Additional Central Assistance for Externally Aided Projects payable in the year 2016-2017 under **Reimbursement Procedure on back to back basis** as below:

However, the balance amount of Rs **10.29 lakh** (as mentioned at Sl. No. 02 of the said letter) is being released vide Sanction No. 53(2)/PF-I/2015-1615 dated 23.01.2017 being 10% Loan.

3. The Payment may kindly be released to the State Governments immediately. (State Government may release the funds to the project authorities within 7 days of receipt , failing which Government of India could claim interest on the undisbursed funds held with the State Government).


