**Subject : Release of Grants-in-aid to the States for Non-Nutrition Provision under the Scheme for Adolescent Girls (SAG) during 3<sup>rd</sup> quarter of 2017-18.**

Madam/Sir,

I am directed to convey the sanction of President to the payment of Rs.29.95 lakh (Rupees twenty nine lakh ninety five thousand only) to the following State Governments to the extent of amount indicated against each as grants-in-aid during 3<sup>rd</sup> quarter of 2017-18 towards GoI's share (90%) for implementation of Non Nutrition component under the Scheme for Adolescent Girls :

2. The expenditure on the Non-Nutrition component of the Scheme for Adolescent Girls is subject to annual budgetary ceiling of Rs.3.8 lakh per project and due adherence to the extant rules and procedures in this matter.

3. The State Governments will maintain separate records of expenditure incurred for implementation of Non-nutrition component under the Scheme for Adolescent Girls and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure on Non Nutrition component from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July, for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October, from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of each State Government.

4. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will be shared between the Central and State Governments in proportion with their respective shares in the capital cost to assets.

5. The Scheme for Adolescent Girls is Centrally Sponsored Scheme in which the Centre and States/UTs both have contributions. The cost sharing ratio for the Scheme for Adolescent Girls has been revised from the financial year 2016-17 to 90:10 between the Centre and the State (for Himalayan States). The above funds are being released to States on the basis of new cost sharing ratio and is subject to the following conditions:

- i. The amount of grant will have to be utilized for all the components under the Schemes as per the schematic norms;

- ii. The States shall also be required to contribute adequate amount for implementation of the Scheme for Adolescent Girls.
6. The expenditure is debitible to the Major Head "3601" Grants-in-aid to State Governments: Sub-Head: 06-Centrally Sponsored Schemes, 06.101-Central Assistance/share, 47-Integrated Child Development Services Scheme (ICDS),47.05- Scheme for Adolescent Girls, 47.05.31-Grants-in-aid General in Demand No.99 Ministry of Women & Child Development 2017-18 (Plan).
7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.
8. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
9. This sanction issues with the concurrence of IFD vide their Dy.No.31023/JS&FA Dated 10.11.2017.
