**Subject: Release of funds to State Government of Himachal Pradesh under BBBP for F.Y. 2023-24 – reg.**

Madam/Sir,

I am directed to convey the sanction of the President to the payment of **Rs.2,80,39,017/-** (Rupees Two Crores Eighty Lakh Thirty Nine Thousand Seventeen only) to the **State** Government of Himachal Pradesh as grants-in-aid during the financial year 2023-24 for implementation of Beti Bachao Beti Padhao (BBBP) Scheme in 12 districts ( as per list )

2. It may be noted that the amount allocated to each district has been categorized in three bracket based on the SRB of the district. The three categorization are @ Rs. 40 lakh, Rs. 30 lakh and Rs 20 lakh per annum. The details of amount allocated to each of the 5 districts are annexed herewith. **It may be noted that under the scheme, there is no provision for creation of any type of capital asset or direct financial benefit to any individual.** It may be ensured that the expenditure is made as per the schematic norms( kindly refer operational manual of BBBP available on Ministry's Website [www.wcd.nic.in](http://www.wcd.nic.in)). The component wise maximum ceiling of is as under:

Sl.	Activities	Maximum ceiling in each component based on allocation ( in percentage)
i	Sectoral activities of Department of Women and Child Development (i) Capacity Building, (ii) Orientation and Sensitization, (iii) Outreach (iv) Innovation (v) IEC material (vi) Monitoring and Documentation	50%
ii	Sectoral activities in Convergence with partner and line Departments	40%
iii	Flexi Fund	10%

3. The fund are to be utilized directly by the District Administration for any of the activities listed in operational manual/ activity calendar/ or other activities in line with the overall aim and objective of BBBP. **It is pertinent to mention that each district is mandated to organize plantation drive.**

4. The District Administration will maintain separate records of expenditure incurred for implementation of BBBP and they are required to furnish separate Statement of Expenditure along with Physical Progress Report and Utilization Certificate, directly to their State Department. The State Government will submit Utilisation Certificate and Statement of Expenditure to Ministry of Women and Child Development, GoI within 15 days of the start of next Financial Year.

5. The expenditure is debitale to 3601.06.101.82.01.31 Grants-in-aid General of Sambal Sub scheme in Demand No. 101 Ministry of Women and Child Development for the financial year 2023-24.
6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State of Himachal Pradesh would be arranged through NEFT/ECS. **The Payment of the State Government would be arranged through CAS, Reserve Bank of India, Nagpur.** The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.
7. The accounts of the Grantee Institutions or Organisations shall be opened to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department in terms of Rule 236(1) of GFR, 2017.
8. The State shall implement all provisions contained in the letter of the Department of Expenditure, Government of India dated 23rd March 2021 regarding SNA. The funds are to be transferred to SNA account of State of Himachal Pradesh through treasury. State Govt. of Himachal Pradesh will ensure that all the districts zero balance accounts are linked to the State's SNA account.
9. Consolidated UC from the State Government of Himachal Pradesh has been received. The unspent amount available as on 14.01.2024 is Rs.29.60983 Lakhs.
10. As per Rule 232 (v) of GFR 2017, funds are being transferred to the State Government through PFMS and State Government will transfer funds to Districts through PFMS and District Administration will also follow the provisions of Rule 232 (v) of GFR in monitoring and utilization of funds.
11. This sanction issues with the concurrence of AS &FA , WCD vide computer No.73767 dated 23.01.2024.
12. Entry has been made in Sanction Register at Sr. No. 20 of F.Y. 2023-24.
