**Sub: Release of funds to Govt. of Himachal Pradesh in respect of IHHL Units under Swachh Bharat Mission during 2019-20 - reg**

Sir,

I am directed to convey the sanction of the Competent Authority for release of **Rs. 4,67,98,400/- (Rupees Four Crore, Sixty Seven Lakh, Ninety Eight Thousand Four Hundred only)** to **Govt. of Himachal Pradesh** towards release of 2<sup>nd</sup> Installment for construction of 5318 IHHL Units @ Rs.8800/- per unit under Swachh Bharat Mission (Urban) during 2019-20.

2. The sanction will be regulated in accordance with the provisions of GFR, 2017.
3. The expenditure is debitable to Major Head **3601** – (Grants-in-Aid to State Govts) – **06** – (Centrally Sponsored Schemes) – **101** – (Central Assistance/Share) – **22** – (Swachh Bharat Mission) – **03** – Project Fund – **35** – Grants for creation of Capital Assests under **Demand No. 56** for the year 2019-20 of the Ministry of Housing and Urban Affairs.
4. The amount will be credited to the State Government's account in RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) dated 22.02.1977.
5. In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at [www.mohua.gov.in](http://www.mohua.gov.in) and following the same while releasing funds to beneficiaries/ULBs, the release of funds for construction of **Individual Household Toilets** will be restricted to and governed by the guidelines given in relevant paragraph of the SBM guidelines.
6. Entry has been made at Sl. No. **103** in the Grant-in-Aids Register for the year 2019-20.
7. No U.C. is pending for these project from **Govt. of Himachal Pradesh**.
8. This issues with the approval of Finance Division vide Note on **e-file No.3107431 dated 30.09.2019**.


