3. The above **additional amount** of loan under **Part-I** (Untied) of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' towards capital projects communicated vide Department of Expenditure letter No. 44(1)/PF-S/2024-25 (CAPEX)-Himachal Pradesh dated 11.03.2025 is being released based on the guidelines of the Scheme issued by the Department of Expenditure vide letters No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024, 15.05.2024, 09.08.2024, 19.08.2024, 22.10.2024, 20.12.2024 & 13.02.2025 and 44(1)/PF-S/2024-25(CAPEX)(Pt.) dated 08.05.2024 and revised proposal recieved from the State Government of Himachal Pradesh vide letter No. PLG (Pl) 1-42/2024 dated 18.02.2025 in continuation to its earlier letters dated 09.01.2025, 22.01.2025 & 27.01.2025, subject to the following conditions:

- i. The amount released by the Union Government shall be released to the Implementing Agencies of the State Government within 10 working days. Delay beyond this period will make the State liable to pay interest to the Government of India on the amount released as per the weighted rate of interest on Open Market Borrowings (i.e. 10 year G-Sec.) for the previous year.
- ii. The amount released shall be utilized by 31.03.2025. Release of funds to intermediate agencies without actual payment to the final recipient (parking of funds) will not be treated as expenditure.
- iii. The State Government shall ensure that there is no duplication in funding of the capital projects approved under the Scheme either with the funds provided by the Government of India or the State Government.
- iv. In case of unavoidable changes in the specific project for which funds are being released, the State Government shall seek the approval of the Government of India for the change. Funds will not be provided in case of un-approved changes.

Titewha were

- v. Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes/duties due to the State in subsequent periods.
- vi. All provisions of the guidelines of the Scheme issued vide letters No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024, 15.05.2024, 09.08.2024, 19.08.2024, 22.10.2024 & 20.12.2024 and 44(1)/PF-S/2024-25(CAPEX)(Pt.) dated 08.05.2024 and subsequent amendments, if any, shall be applicable in toto and shall be strictly adhered to by the State Government of Himachal Pradesh and its implementing agencies.
- vii. Violations of mandatory conditions detailed in Para (9) of the Scheme guidelines issued vide letter No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024 and further amendments thereto, if any, will result in the deduction of amounts by the Government of India from devolution of taxes to the State.
