The undersigned is directed to convey the sanction of the President of India to the payment of Rs. 2500.00 Lakh (Rupees Twenty Five Crore Only) being the balance approved amount under Part-II (Release of Balance Approved Amounts under Part-V, Part-VI and Part-VII of the Scheme for 2023-24) of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' under Demand No. 42 of Department of Expenditure to the State Government of Himachal Pradesh for the financial year 2023-24 as under:

- 3. The amount of above loan is towards the balance approved amount under Part-V(Housing for Police personnel above or as part of Police Stations in Urban Areas) of the 'Scheme for Special Assistance to States for Capital Investment 2023-24' and released under Part-II (Release of Balance Approved Amounts under Part-V, Part-VI and Part-VII of the Scheme for 2023-24) of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' for the capital projects communicated vide Department of Expenditure letter No. 44(1)/PF-S/(CAPEX)Part-V/2023-24 dated 08.08.2023 and is being released based on the Scheme guidelines issued by Department of Expenditure vide letters No. 44(1)/PF-S/2023-24 CAPEX dated 03.02.2023, 02.05.2023, 19.05.2023, 26.05.2023, 16.06.2023, 19.06.2023 & 31.07.2023 and Scheme guidelines issued vide letter No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024 and subsequent amendments, if any, and utilization certificate received from State Government of Himachal Pradesh vide letter No. PLG (Pl) 1-42/2023 dated 08.02.2024 and information provided by PFMS Division regarding deposition of Central share of interest earned in SNA accounts under Part-V of the Scheme for 2023-24 in Consolidated Fund of India, subject to the following conditions:
  - i. The amount of loan under Part-V of the Scheme is earmarked for the capital projects for 'Housing for Police personnel above or as part of Police Stations in Urban Areas' in the State of Himachal Pradesh approved under Part-V of the Scheme and communicated to the State Government of Himachal Pradesh vide letter No. 44(1)/PF-S/(CAPEX)Part-V/2023-24 dated 08.08.2023.
  - ii. Violation of conditions as detailed in Para (3) of the supplementary guidelines issued by Department of Expenditure vide letter dated 02.05.2023, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
  - iii. The amount released by the Union Government shall be released to the SASCI nodal agency (being the implementing agency for this Part of the Scheme) of the State Government within 10 working days.
  - iv. The amount released shall be utilized by 31.03.2025. Release of funds to intermediate agencies without actual payment to the final recipient (parking of funds) will not be treated as expenditure.

- v. The State Government shall ensure that there is no duplication in funding of the capital projects approved under the Scheme either with the funds provided by the Government of India or the State Government.
- vi. Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
- vii. Violations of mandatory conditions detailed in Para-4(ii) and Para-4(iii) of the Scheme guidelines issued vide letters No. 44(1)/PF-S/2023-24(CAPEX) dated 03.02.2023 and 19.05.2023 will result in the deduction of amounts by the Government of India from devolution of taxes to the State.
- viii. All provisions of the guidelines of the Scheme issued vide letters No. 44(1)/PF-S/2023-24 (CAPEX) dated 03.02.2023, 02.05.2023, 19.05.2023, 26.05.2023, 16.06.2023, 19.06.2023 & 31.07.2023 and Scheme guidelines issued vide letter No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024 and subsequent amendments, if any, shall be applicable in toto and shall be strictly adhered to by the State Government of Himachal Pradesh and its implementing agencies.
