Sir,

The undersigned is directed to convey the sanction of the President of India to the payment of **Rs. 4233.00 Lakh (Rupees Forty Two Crore Thirty Three Lakh Only)** being the 2nd instalment of loan under Part-IX of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' under Demand No. 42 of Department of Expenditure to the State Government of Himachal Pradesh for the financial year 2024-25 as under:

2. Payments may kindly be made to the State Government immediately.

3. The amount of above loan is the 2nd instalment during 2024-25 under Part-IX (State's Share of Centrally Sponsored Schemes Including Urban and Rural Infrastructure Projects) of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' towards capital projects communicated vide Department of Expenditure letter No. 44(1)/PF-S/2024-25 (CAPEX)-Himachal Pradesh dated 14.10.2024 and is being released based on the guidelines of the Scheme issued by the Department of Expenditure vide letters No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024, 15.05.2024, 09.08.2024, 19.08.2024, 22.10.2024 & 20.12.2024 and request alongwith Utilization Certificate received from the State Government of Himachal Pradesh vide letter No. PLG (PI) 1-42/2024 dated 16.12.2024, subject to the following conditions:

- The amount released by the Union Government shall be released to the Implementing Agencies of the State Government within 10 working days. Delay beyond this period will make the State liable to pay interest to the Government of India on the amount released as per the weighted rate of interest on Open Market Borrowings (i.e. 10 year G-Sec.) for the previous year.
- The amount released shall be utilized by 31.03.2025. Release of funds to intermediate agencies without actual payment to the final recipient (parking of funds) will not be treated as expenditure.
- The State Government shall ensure that there is no duplication in funding of the capital projects approved under the Scheme either with the funds provided by the Government of India or the State Government.
- In case of unavoidable changes in the specific project for which funds are being released, the State Government shall seek the approval of the Government of India for the change. Funds will not be provided in case of un-approved changes.
- Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes/duties due to the State in subsequent periods.

- vi. All provisions of the guidelines of the Scheme issued vide letters No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024, 15.05.2024, 09.08.2024, 19.08.2024, 22.10.2024 & 20.12.2024 and 44(1)/PF-S/2024-25(CAPEX)(Pl.) dated 08.05.2024 and subsequent amendments, if any, shall be applicable in toto and shall be strictly adhered to by the State Government of Himachal Pradesh and its implementing agencies.
- vii. Violations of mandatory conditions detailed in Para (9) of the Scheme guidelines issued vide letter No. 44(1)/PF-S/2024-25 (CAPEX) dated 26.02.2024 and subsequent amendments thereto, if any, will result in the deduction of amounts by the Government of India from devolution of taxes to the State.
